

LAW ENFORCEMENT MANAGEMENT SYSTEM (LEMS)
Intelligence/Informant System

The Intelligence/Informant System is designed to allow your department to maintain an intelligence file outside of the regular Master Name file. Intelligence information is entered into this system typically by the investigations department and maintained solely by them. Since this type of information necessitates a higher level of security, it does not interface with any other LEMS applications.

The basic information mirrors the information requested in Master Name, such as name, address, DOB, Eyes, Hair, etc. The actual intelligence information screen is patterned after the MOCIC data submission format.

SYSTEM HIGHLIGHTS:

- o Allows for on-line entry of Intelligence information patterned after MOCIC.
- o Basic input similar to Master Name.
- o Prints an intelligence list by name.
- o Allows for the viewing of intelligence information by name.
